Store in original unopened containers in temperature from 5 °C to 25 °C. It must not freeze!

Application:

SANAKRYL mat PROFI/TG2 is applied on metal surface, which can be treated with SANAKRYL antikor AY/TG2 PRIMER, by high-pressure airless spraying in thickness of wet coating of up to 170–200 μ m. Minimum surroundings temperature must be 15 °C. After application of the paint, the sheet metal

stencils coated with SANAKRYL mat PROFI/TG2 are left to dry at normal temperature for a maximum of 5 minutes and then moved to the drying room where they are dried at a temperature of up to 80 °C for 50 minutes. Used tools must be washed with water after the finish of work.
